Special Requirements for Foreign Wires

Cutoff time for submitting foreign wires is 4:00PM.

The following countries require Bank Codes for the Beneficiary Banks on all wires (please place Bank Codes in field named "Payee FI R/T Number" or "For Further Credit"):

- BSB Code for **AUSTRALIA**: 6 digits.
- BSB Code for **NEW ZEALAND**: 6 digits.
- Clabe for <u>MEXICO</u>: 18 digits (includes beneficiary account number along Bank Code and Branch Office Code). The Clabe goes in the Beneficiary account number field, like an IBAN.
- Transit Code for <u>CANADA</u>: 5 digits branch code and 3 digit financial institution code.
- Branch Code for **SOUTH AFRICA**: 6 digits.
- POP Code and IFSC Code for <u>INDIA</u>: POP Code, or Purpose of Payment Code, consists of 1 letter and 4 digits; IFSC code is an 11 character code. Both are required. Please place in "For Further Credit" field. This field has a 35 character limit.
- Bank Routing Code for <u>INDONESIA</u>: 7 digits. Please place the next 3 items in "Payment Notes" field: a Purpose Code, Reason for Payment, and Relationship with Beneficiary Letter Code:
 - 1. "G"—Group
 - 2. "P"-Shareholder
 - 3. "T"-Subsidiary
 - 4. "N"-Not Related
- And a special note for wires to <u>CHINA</u>: Beneficiary name must
 match exactly, including commas, periods, and words such as
 "Co.". "Ltd." and the like. If the full beneficiary name does not
 fit on the line given, please use address line 1 for the remainder
 of the name.

Purpose of this wire (this is a Compliance requirement). Please do not use generic purpose, such as "To Pay Invoice". Instead, describe the payment accurately: "To Buy Auto Parts", "To Import Coffee Beans", etc. Please place in "Payment Notes" field. This field has a 70 character limit.
